We herby declare that semi finished product made of above mentioned material have been tested according the following legislation:

- 1.) regulation (EG) Nr. 1935/2004 from 27.10.2004 for materials applied in food industry
- 2.) regulation (EU) Nr. 10/2011 from 14.01.2011 for plastics applied in food industry

Based on the migration tests performed the overall as well as specific migration are within required limits (S/V = 6). The material is conform with OM4 requirements regarding food simulant A, B and D2 (see (EU) 10/2011).
